Toogoolawah State High School offers flexibility to families through a range of payment methods for your convenience.

Internet Banking

Direct Payment into the School Bank Account:

Reference/Details: Please record both Student Number (on Student's ID Card) AND Reference Code in the reference/details section so that your payment can be recorded correctly.

It is very important that you are accurate with your payment description. If we cannot identify your student or what you are paying for, we cannot allocate the payment correctly. Please note – to ensure payment reaches the school's bank account prior to the payment cut-off date, all internet bank payments must be made no later than 48 hours prior to the cut-off date.

Centrelink Deductions

These are available to families who wish to have a fixed amount deducted from their Pension / Newstart Allowance / Family Tax Benefit and applied to their child's account. Forms are available from the School Office and when completed, please return the form to the Business Manager for processing. Minimum fortnightly deduction is \$15.

Eftpos

This method is still available from 8:00 am to 3.00 pm Monday – Friday.

BPoint

Paying fees / excursions / activities directly to the school over the internet with your debit/credit card. This method is provided to you 24 hours a day, 7 days a week. When school invoices are emailed just click on the BPOINT link located at the bottom of the OneSchool finance invoice or via the website. This will open up the BPOINT web page and pre-populate the CRN, invoice and student name details, part payments are also accepted.

BPOINT IVR (Interactive Voice Response) Telephone Payments

This number is included on all OneSchool invoices - Call 1300 631 073. Student CRN and invoice number are required.

BPOINT eDDR (Electronic Direct Debit Registration) Payment Plan

Parents/customers are provided a link to register their debit/credit card or bank account for direct debit regular payments. To setup, please contact the School.

Deduction Authority Consent

I give permission for the Department of Human Services to make a Deduction each fortnight from my Benefit and pay this amount to Toogoolawah State High School.

I give permission for the Department of Human Services to disclose my information to Toogoolawah State High School for the purposes of checking my account number, billing number and amount I wish to pay, and reconciling my payment deduction details. I also authorise Toogoolawah State High School to give the Department of Human Services my correct account and billing number if required.

I understand that:

- It is my choice to have this amount deducted from my Centrelink payments, and that I can change or cancel the Deduction at any time by contacting the Department of Human Services or Toogoolawah State High School.
- If I have a current Centrepay Deduction and I transfer to another eligible Centrelink payment in the future, my Deductions may continue.
- If I have a current Centrepay Deduction and I lodge a new claim for Centrelink payments, the existing Deduction(s) will not be carried over to the new payment and I will have to provide new Deduction Authorities to have these set up when the new payment is granted.
- If I stop using Toogoolawah State High School's services but do not stop my Centrepay Deduction, Toogoolawah State High School may instruct the Department of Human Services to stop the Deduction.
- If my Deduction has a target amount and the final Deduction is set to pay less than \$2.00, my second last Deduction will be increased by up to \$2.00 to cover the final amount.
- The Department of Human Services will notify me in writing of any changes to my Deduction details including changes requested by Toogoolawah State High School.
- My Deduction Authority consent will be noted on my account record with Toogoolawah State High School.
- When a payment has been made to Toogoolawah State High School after my Deduction Authority has been cancelled or suspended, the Department of Human Services, may be able to assist me to recover the Centrepay Deduction.
- If I cease to be a customer of Toogoolawah State High School, I will advise the Department of Human Services and Toogoolawah State High School to stop my Deduction.
